# **COMMITTEE UPDATE**

Although the Minutes of our Committee Meetings are available on the club noticeboard, a brief update on some of the more topical issues currently being worked by your Committee include;

## **Cyclone Gabrielle Relief Fund**

You will no doubt be aware of the NZ Bridge advice regarding the initiative of the New Zealand Bridge Foundation to raise money to help Bridge clubs and players adversely affected by the aftermath of Cyclone Gabrielle. The Chair of NZ Bridge has commented that 'every bit helps'.

While the Waikanae players who visited Paraparaumu in early March for the combined Interclub Shield/Charity event contributed to the \$1,066 raised for the Cyclone Gabrielle affected Bridge Clubs, the wider Waikanae Club members have not had the opportunity to contribute to this initiative.

As such, the Committee is inviting members to consider making an electronic contribution to the Waikanae Bridge Club bank account, citing 'Gabrielle' in the Reference field. Cut-off is 30 April. In early May, the Treasurer will forward the total funds contributed to the New Zealand Bridge Foundation. Unfortunately, we cannot issue a Tax-Deductible certificate for these donations.

We will advise the membership of the total funds raised in the May Newsletter.

## **Carpark Lighting**

Our insurance claim has been accepted and the reinstallation of the carpark lighting has been handed to our electrical contractors. Entire Electrical have advised this week that the light poles are expected to be delivered around 2 June – while certainly later than anticipated, we can be thankful progress is underway.

## **Bridge Club Lease**

We are delighted to advise that the lease negotiations are now

complete. The new lease documents giving us 10-years with the right of a further 10-years (overall a 20-year security of tenure) has been signed by the Bridge Club. The lease documents are now with KCDC for their signature.

On behalf of us all, I offer sincere thanks to Ady Dale and her team of Graham Cheater, Rae Lutman, Vicky Young and Hugh Wolfensohn (not forgetting our legal consultant John O'Regan of Brandon's Lawyers) for bringing these convoluted negotiations to an acceptable conclusion for the Bridge Club.

The HAV Review is underway. The sub-committee is expected to report back to the Committee with recommendations by 30 May. This report will be considered by the June Committee meeting.
