MEETING WITH PARAPARAUMU BRIDGE CLUB

You may recall that there was one issue that I undertook to update this month. Paraparaumu asked us to consider the possibility of Joint Membership of both clubs in that a member of either club would have joint membership to play in the other club. They proposed that while paying no Membership fee in the other club, any member playing in the other club would pay the Visitor table money fee.

We are aware that the likes of Tauranga and Mt Maunganui have an arrangement between them – however, they are the only two clubs in the area. We acknowledge Paraparaumu being our close neighbours, however we also have a number of valued members from Otaki and Levin. In noting the potential financial implications and after some considerable discussion, your committee agreed that we maintain the status quo. We have advised Paraparaumu of our decision.

TEMPERATURE & VENTILATION/MAINTENANCE

While the T&V policy issues have been dealt with and in the main implemented, the one outstanding issue is the fitting of the catches to limit the opening of the windows on two of the North wall windows. Action to complete this is expected to be completed over the next week or two.

COMMITTEE UPDATE

The following provides an insight into the range of issues dealt with at recent Committee meetings;

NZ Bridge AGM

The Annual AGM will be held in September in conjunction with the NZ Bridge Congress to be hosted in Tauranga. All Clubs are required to advise NZ Bridge by the end of August as to who their representative will be at the AGM.

Communications Review

This remains on the 'work list'.

KCDC Blackboard Request

KCDC have now withdrawn their request for us to host a blackboard on our Club for an upcoming KCDC survey.

KHAP Meeting at Otaki Bridge Club

Graham Cheater and I attending a meeting in late May which undertook a review of the KHAP Autumn series, considered the venue/format of the upcoming Spring series and discuss the 2024 future of the competition.

It was noted that;

- the Spring series will continue as a face-to-face format at Otaki beginning in September.
- Paraparaumu offered to host the 2024 competition on Thursday club nights
- a survey of KHAP club members will be undertaken in September to determine the format of the competition.

Separate the 2023 Junior and Intermediate tournaments

It was agreed to trial separate our Junior and Intermediate tournaments in 2023.

- a one session Junior tournament will be held on Sunday 29 October with two group session prizes; one for Juniors and one for Novices.
- The Intermediate tournament will be held on 5 November as originally scheduled.

The Club has forwarded a request to the Wellington Regional Committee to seek agreement and support in recommending this to NZ Bridge.

2024 Club Programme Book

Rae Lutman and Ady Dale have commenced work on the 2024 Programme Book layout so that it will be ready to lodge with the printers by mid-November. The cost to advertisers will increase to \$100.

The Waikanae Bridge Club 50th Jubilee

The club's 50th Jubilee celebration has been confirmed as

Saturday, 4 May 2024. A limit of 96 members and past members will be invited to play in an in-house 'Goulash' tournament after a meet and greet and a potluck lunch. After match drinks, cutting of the cake and afternoon tea will follow. The sub-committee has the preparation of a Jubilee booklet well in hand.

NZ Bridge Tournament Session Charges Increase

To finish off, here is the explanation of the upcoming tournament charge increase to which I referred last month.

A NZ Bridge Bulletin dated 8 May advised that the Board of NZ Bridge had taken decisions to create and fund a Communication, Marketing and Relationship Manager position; **and**, invest in the development of a <u>**Club and**</u> <u>**Regional**</u> toolkit of resources and support, that with the creation of a pool of skilled contractors, will provide practical support at club level, from administration, governance to marketing and beyond.

Under this second aspect, the Bulletin went on - quote:

"Having reviewed our options, and wanting to minimize the impact to club play, we have decided to **increase the cost of A and B point tournament pair sessions** and the cost of team and swiss events only. No change in the cost of fractional masterpoints. The cost of A and B point events last changed in 2007, and our expectation is that tournament players will support the increase, recognizing that it is going back into the welfare and development of the game.

Having reviewed our options, and wanting to minimize the impact to club play, we have decided to increase the participation fees for tournaments*:

- The participation fee will increase from \$1.00 (+gst) per player per session to \$2.50 per player per session (+gst)
- For teams and swiss pairs tournaments where the charges are calculated on a "per board played" basis, the fee will increase from 4 cents (+gst) per board per player played to 10 cents (+gst) per player per board played.
- There will be no increase in the charges for fractional and full A points awarded.

- There will be no change to the participation fees for club sessions.
- There will be no change to the player levy.
- These changes will not come into force until 1 November 2023 allowing sufficient time to review and amend the cost of your events if that is required.

In the coming days we will add a second "cost estimator" to the following page on our website so that indicative costs can be calculated for events scheduled from when the increase will take place https://www.nzbridge.co.nz/estimatorfor-tournamentmasterpoint-fees.html

In addition to the provision of a toolkit for clubs we now plan to extend the service to include a toolkit for the regions.

Clearly the additional funds derived from the changes mentioned above mean we will have more funds available to support the grass roots of the game by providing general and targeted support; help with growth and improved participation; and raising the quality and skills of our players.

In summary:

- 1. The engagement of a marketing, communications, and relationship manager.
- 2. Pay for the development of a club and regional toolkit.
- 3. Creation of a pool of skilled contractors who will be available for clubs to access.
- Increase in the cost of tournament* participation fees \$1.50 per session for pairs events, and for teams and swiss events 10 cents per board, all +gst.
- 5. Change effective from 1 November 2023.

An exciting time ahead as we add resources and services and position our game to thrive in the future. As always feel free to contact me or Alister should you require additional information.
