NZ Bridge AGM

Vivienne Cannell has graciously offered to represent the Club at the Annual AGM on 22 September in conjunction with the NZ Bridge Congress in Tauranga. Thank you Vivienne.

Monday Session – Doubling for Penalties

The Committee has made the decision to end the rule of 'No Doubling for Penalties on Mondays' as of 30 September 2023.

Therefore, from Monday 2 October, Penalty Doubles are permitted as an integral part of normal play. This notwithstanding, I would ask that experienced players be mindful of players from this year's New Beginners class. Thank you.

This process is again underway. A building inspection is pending.

The Club Constitution

You may recall that we introduced this issue in the last Newsletter. Following the tabling of an excellent update to brief the Committee members at our last meeting, Pat Stuart kindly provided me with the following brief for our wider membership.

'The new **Incorporated Societies Act 2022** will come into force on 5 October. Waikanae Bridge Club is incorporated under the Incorporated Societies Act 1908 (the current Act) and is eligible to reregister under the new Act. We can apply to reregister at any time from 5 October 2023 to 5 April 2026.

To reregister we must have the agreement of the membership and a constitution that complies with the new Act.

The Committee has started this process by gathering information and the development of the new constitution will start in earnest once a promised template is available. This will be an iterative and consultative process and may be the subject of a Special General Meeting before the new constitution is put to the membership for approval at an Annual General Meeting (AGM).

A key first step will be to obtain the agreement of the membership to reregistration and the Committee resolved at its meeting on 11 September to do this through a motion at the 2024 AGM.

The purpose of Incorporation is to provide a legal entity to allow the business of the Club, such as entering into contracts, to be undertaken. For those of you interested in finding out more, this link to the <u>Companies Office</u> website provides information on the changes for incorporated societies.'
